THIS IS OUR RIGHT. THIS IS OUR CHOICE. OUR VOICES ARE HEARD!

In December, the United States Civil Rights Commission began hearing some <u>anti-workshop</u> <u>testimony</u> against 14C, the Federal law that allows workshops to employ a wide range of people with a wide range of abilities. (Remember: Missouri is unique, and everyone has tried competitive employment first, and always still have the option to be employed competitively).

The testimony that was submitted had multiple inaccuracies and called parents who choose workshop employment "ignorant and uninformed". Although they have no authority to act, the Commission planned to render a recommendation in January 2020.

Lafayette families joined families from 18 states and shared our personal experience and support of sheltered workshops through a letter writing campaign. We shared that the focus on wages ignores the larger picture. We are NOT concerned with lower pay. We ARE concerned that the rights of our *family member* to work in a fulfilling, safe, stable job where he enjoys being part of a community is at risk due to the wage debate.

WE DID IT!!

The U.S. Civil Rights Commission received approximately 10,000 letters from across 18 states regarding the importance of 14C and employment of choice. Between the letters and personal testimonies the Commission has decided to take more time to research before making a recommendation. They pushed the date to make a recommendation to September 2020 AND they are officially visiting several sheltered workshops as a group to expand their research.

FAREWELL, BRADLEY

I met Bradley Ragsdale back in 2010 at work, and we instantly hit it off. Somehow we knew we wanted to be more than just friends. So a few weeks later, when God took my previous boyfriend, Tim, who did not work at Lafayette, back to Heaven, of course I was devastated. Bradley was in the right place at the right time, and he gave me a friendly shoulder to cry on – literally. We exchanged cell numbers so we could text, and we always knew how to make each other happy.

Bradley was born on August 21, 1986, the oldest son (look-a-like and namesake) of Brad and Dawnita Ragsdale, and older brother to Brandon. He had Asperger's Syndrome (a mild form of autism). His mother got very sick, and died when he was four. This was one of the things that attracted me to him -- I lost my father when I was 15.

August 4, 2010, was a day that changed both of our lives forever. All Bradley was trying to do was get a bus ride home from work when he was hit by a drunk driver who was high on drugs. Poor Bradley had to spend the last 10 years of his life in a nursing home and had to be put on a liquid diet. He also had to have a tracheotomy to help him breathe, and he was paralyzed from the waist down due to the accident. He also had to wear adult diapers, which he hated, and he spent most of his time in a large electric wheelchair or in bed. I told him he had a "very long, uphill battle" ahead of him, and I was right.

Sadly, the "very long, uphill battle" ended on December 21, 2019. I found out via social media that Bradley had passed away that morning. Eight days later his family had a very nice memorial service for him. His Aunt Sue, who is now my friend, gave me a picture magnet of me and Bradley, an 8 x 10 photo of him by himself and some flowers.



2019 TAX PREPARATION GUIDELINES

The AARP Tax Aide Foundation provides no-cost tax preparation for taxpayers needing assistance. All Counselors are AARP / IRS trained and certified each year. Intake / Quality Review forms are available at the West Office. To prepare for your tax return appointment, please bring the following:

Completed Intake / Quality Review Form Last year's (2018) tax return Wage income – W2 forms Gambling winnings / losses – W2G forms Retirement Pension income – 1099R forms Social Security pension or disability income – SSA 1099 form If receiving SSI, then a copy of the letter from SSI listing amount to be paid in 2019 Interest from banks / brokers - 1099 INT forms Dividend income from companies / brokers - 1099 DIV forms Capital gains / losses from broker's 1099B forms and / or brokerage statements (If expecting a brokerage report recommend scheduling appointment after March 1st.) Health care insurance premiums for everyone listed on return Nursing home insurance premiums Employer / Government health care insurance coverage forms - 1095A, 1095B or 1095C If you itemize (commonly called the long form) – Unreimbursed medical bills and medical mileage Home mortgage interest Real Estate tax receipts Personal Property tax receipts

Charity contributions and volunteer mileage

Picture ID, proof of address, age and social security cards for all people listed on tax return. The IRS encourages direct deposit of refunds. To use direct deposit, bring a blank check or savings account deposit slip for account number verification. If you or anyone on your tax return was a victim of identity theft, the identity pin number issued by the IRS in December is needed to efile the return.

Those over 65, certain widow/ers over 60 or those permanently totally disabled may quality for the Missouri Property Tax Credit (also called "Circuit Breaker"). This credit is for lower income residents that own or rent their home. If you rent a non-government subsidized home then bring a letter from your landlord with their name, tax identification number, address, telephone number that states the number of months and total amount of rent paid. If you own your home, bring the paid real estate tax receipt.

Tax returns will be completed on the IRS computer tax preparation system and efiled with the IRS. Federal income, state income and property tax credit (if applicable) forms are completed as one package.
