#### **SAFETY THOUGHTS FOR SEPTEMBER 2024**

#### SDS's

Whoa! What in the world is *THAT* Safety Captain? My friends, it's only one of the most important parts of any corporate safety plan. The letters are an acronym for the *Safety Data Sheets*. They are documents that come with every chemical that is in use at an industrial plant such as ours. The information in them enables all users to confidently work safely with a chemical product. They come with or can be sent to us from the

producers of each product. From the glass cleaner we use on our windows to the metal solvents we might use in our tool shops, all have SDS's.

They each contain information about usage, storage, handling, and any emergency response that relates to the material being used. Our Safety Committees at Lafayette Industries keep these sheets up to date for us in a large (very large) binder near or in each of the production offices.

It can be a difficult job keeping up with it all, and these men and women have to spend a lot of time with it. Consider this: Every new production job that comes into our plants might have new chemicals to be used and a SDS would be needed for each one. They also must be updated from time to time. Some countries, like China for instance, require reviews and updates every 5 years.

Here in the USA, the Occupational Safety and Health Administration states that upon becoming aware of significant new information about a product, we have 3 months to make the update on labels, and 6 months to make updates on the sheets. We should never take the Safety Committees and the people in them for granted. They have a BIG job to do on our behalf. Keeping up with the SDS's is one of them.

Three cheers for the Safety Committee!

the mountain! We had a blast and got very muddy!




#### <u>ADAM BIRDSONG'S 2024 ALASKAN ADVENTURE – CONTINUED</u>

Then in Juneau we went dog sledding. So much fun! The 16 dogs that pulled us were so happy and fast. They are doing their






Our next stop was Ketchikan where we took a Zodiac (inflatable boat) out, and we drove it through
